Bruce County Council has undertaken a partnership with the Bruce and Saugeen Community Futures Development Corporations (BCFDC and SEDC) to advance additional support to local businesses within Bruce County as it relates to the impact of the COVID-19 pandemic. As part of the “Support the Bruce: Business Sustainability Fund”, the “Business Safety Supplies Grant” provides funding to help Bruce County businesses meet Public Health guidelines to keep employees and customers safe from the spread of COVID-19.
